

Resolution No. 509/2014. of the Chief Executive Officer of the Budapest Stock Exchange Ltd.

The Chief Executive Officer of the Budapest Stock Exchange Ltd. (hereinafter referred to as 'Exchange') suspends the exchange trading of the securities named Erste EUR/USD Turbo Long 01 Warrant, ticker symbol: EBEURUSDTL01, ISIN code: AT0000A146N6, issued by Erste Group Bank AG (Graben strasse 21., A-1010 Wien, Austria) (hereinafter referred to as 'Issuer') on October 31, 2014, from 2:33 p.m. for the remainder of the Exchange Day and remove the securities from the Product List at the request of the Issuer.

Last Day of Trading: November 4, 2014

Delisting Date: November 4, 2014

In case the Issuer publishes the amount of the residual value of the structured product and notifies the Exchange in accordance with the relevant Exchange regulations by 12:00 a.m. on November 4, 2014 the Exchange shall resume trading in the securities up to the end of the Last Day of Trading.

The Chief Executive Officer of the Exchange calls on the attention of investors to follow information disclosed by the Issuer on the website of the BSE regarding the residual value of the above structured product.

In accordance with Section 29.2 of the 'Regulations of the Budapest Stock Exchange for Listing, Continued Trading and Disclosure', reasoning of decisions fully approving the applications may be omitted.
