

PROPOSAL AND DRAFT RESOLUTION IN RELATION TO AGENDA ITEM

9 OF THE ORDINARY GENERAL MEETING ENTITLED MODIFICATION OF THE COMPANY'S ARTICLES OF CORPORATION

Pursuant to Book III of Act V of 2013 on the Civil Code ("new CC"), the modification and amendment of the Company's Articles of Association (hereinafter referred to as the "Articles of Association") belong to the scope of the exclusive competence of the General Meeting.

The Company's Board of Directors has summarized the proposals for the modification and amendment of the Company's Articles of Association put forward to the ordinary General Meeting of 2015 as follows.

The Company's Articles of Corporation was last modified by the ordinary General Meeting of 2014. This proposal of the Board of Directors has again suggested the modification of the Articles of Association, with the underlying reason being the change in the composition of the Board of Directors and the election of the auditor for 2015.
