OTP Bank Plc. announces on its own behalf and by proxy of Dr Antal Pongrácz, Deputy Chairman of OTP Bank's Board of Directors, in accordance with Act CXX of 2001 on Capital Markets and 24/2008 PM resolution (Annex 4, point 2.6.), that on 14 May 2013 Mr Antal Pongrácz sold 37,874 OTP shares at an average price of HUF 4,888 per share, with the contribution of OTP Bank as investment service provider.
