

**Resolution No. 209/2013. of the Chief Executive Officer  
of the Budapest Stock Exchange Ltd.**

The Chief Executive Officer of the Budapest Stock Exchange Ltd. (hereinafter referred to as 'Exchange') **suspends** the exchange trading of the securities named **Erste Ezüst Turbo Long 19 Certifikát**, ticker symbol: **EBSILVERTL19**, ISIN code: AT0000A107E7, issued by **Erste Group Bank AG** (Graben strasse 21., A-1010 Wien, Austria) (hereinafter referred to as 'Issuer') **on May 21, 2013, from 8:43 a.m. for the remainder of the Exchange Day and remove the securities from the Product List** at the request of the Issuer.

In case the Issuer publishes the amount of the residual value of the certificate and notifies the Exchange in accordance with the relevant Exchange regulations **by 12:00 a.m. on May 23, 2013** the Exchange shall **resume trading** in the securities up to the end of the Last Day of Trading.
