

Resolution No. 93/2017. of the Chief Executive Officer of the Budapest Stock Exchange Ltd.

The Chief Executive Officer of the Budapest Stock Exchange Ltd. (hereinafter referred to as 'Exchange') suspends the exchange trading of the securities named Esrte OTP Turbo Long 26 Warrant, ticker symbol: EBOTPTL26, ISIN code: AT0000A1TWY2, issued by Erste Group Bank AG (Am Belvedere 1., A-1010 Wien, Austria) (hereinafter referred to as 'Issuer') on February 28, 2017, from 3:40 p.m. for the remainder of the Exchange Day and remove the securities from the Product List at the request of the Issuer.

Last Day of Trading: March 2, 2017

Delisting Date: March 2, 2017

In case the Issuer publishes the amount of the residual value of the structured product and notifies the Exchange in accordance with the relevant Exchange regulations by 12:00 a.m. on March 2, 2017 the Exchange shall resume trading in the securities up to the end of the Last Day of Trading.

The Chief Executive Officer of the Exchange calls on the attention of investors to follow information disclosed by the Issuer on the website of the BSE regarding the residual value of the above structured product.

In accordance with Section 29.2 of the Book Two of the General Terms of Service of the Budapest Stock Exchange Ltd. titled Regulations on Listing and Continued Trading, reasoning of decisions fully approving the applications may be omitted.
