Stabilisation transactions for the period 14-20 July 2017

Budapest, **July 21**, **2017** - In accordance with the provisions of Commission Delegated Regulation No. 2016/1052, WABERER'S INTERNATIONAL Nyrt. announces that stabilisation transactions were carried out in the period of 14-20 July 2017, in respect of the dematerialised, series "A" ordinary registered shares with a nominal value of EUR 0.35 each issued by WABERER'S INTERNATIONAL Nyrt. (Waberer's shares) as presented in the table below.

Stabilisation transactions are carried out by Erste Group Bank AG acting as stabilisation manager for the account of the managers of the Offering of Waberer's shares, as specified in the Prospectus disclosed on June 19, 2017. Stabilisation transactions are carried out at the Budapest Stock Exchange and must end no later than 30 days after the trading of Waberer's shares first commenced on July 6, 2017. After the stabilisation period ends, settlement takes place between the stabilisation manager and the selling shareholder. WABERER'S INTERNATIONAL Nyrt. is not involved in the stabilisation transactions and stabilisation transactions bear no effect on the number of the treasury shares held by WABERER'S INTERNATIONAL Nyrt.
