



Resolution No. 446/2017 Chief Executive Officer of the Budapest Stock Exchange Ltd.

Budapest, December 11, 2017

The Chief Executive Officer of the Budapest Stock Exchange Ltd (hereinafter: CEO) upon the authorization set out in Section 3.2. h) of Book Five of the “General Terms of Service of the Budapest Stock Exchange Ltd.” (hereinafter: Regulations on Trading”), taking Point 32 of the Regulations on Trading into consideration amends the below parameters of ALTERA future contract in the Product List as of December 18, 2017 as follows:
