

Resolution No. 161/2018. of the Chief Executive Officer of the Budapest Stock Exchange Ltd.

The Chief Executive Officer of the Budapest Stock Exchange Ltd. resolved to resume trading in the Erste EUR/HUF Turbo Short 41 Warrant, ticker symbol: EBEURHUFTS41, ISIN code: AT0000A1XK60 structured product issued by Erste Group Bank AG (Am Belvedere 1., A-1010 Wien, Austria) from 12:00 a.m. on May 25, 2018 to the end of the trading day on May 29, 2018.

This resolution shall repeal all provisions of CEO resolution No. **160/2018.** pertaining to the suspension of trading whereas all provisions pertaining to the delisting of the structured product and Residual Value Trading shall remain in force.
