### **Treasury share transaction**

OTP Bank Plc. announces that – according to the Resolution No. 8/2022 of the Annual General Meeting on 13 April 2022, as a part of implementing the Bank’s remuneration policy – on 28 March 2023 the Bank purchased 75,000 own shares at an average price of HUF 9,903 per share on the Budapest Stock Exchange, with the contribution of OTP Bank as investment service provider.

Due to the transaction the stock of own shares owned by the OTP Group has been changed to 943,557 shares. The stock of own shares is 0.34%.
