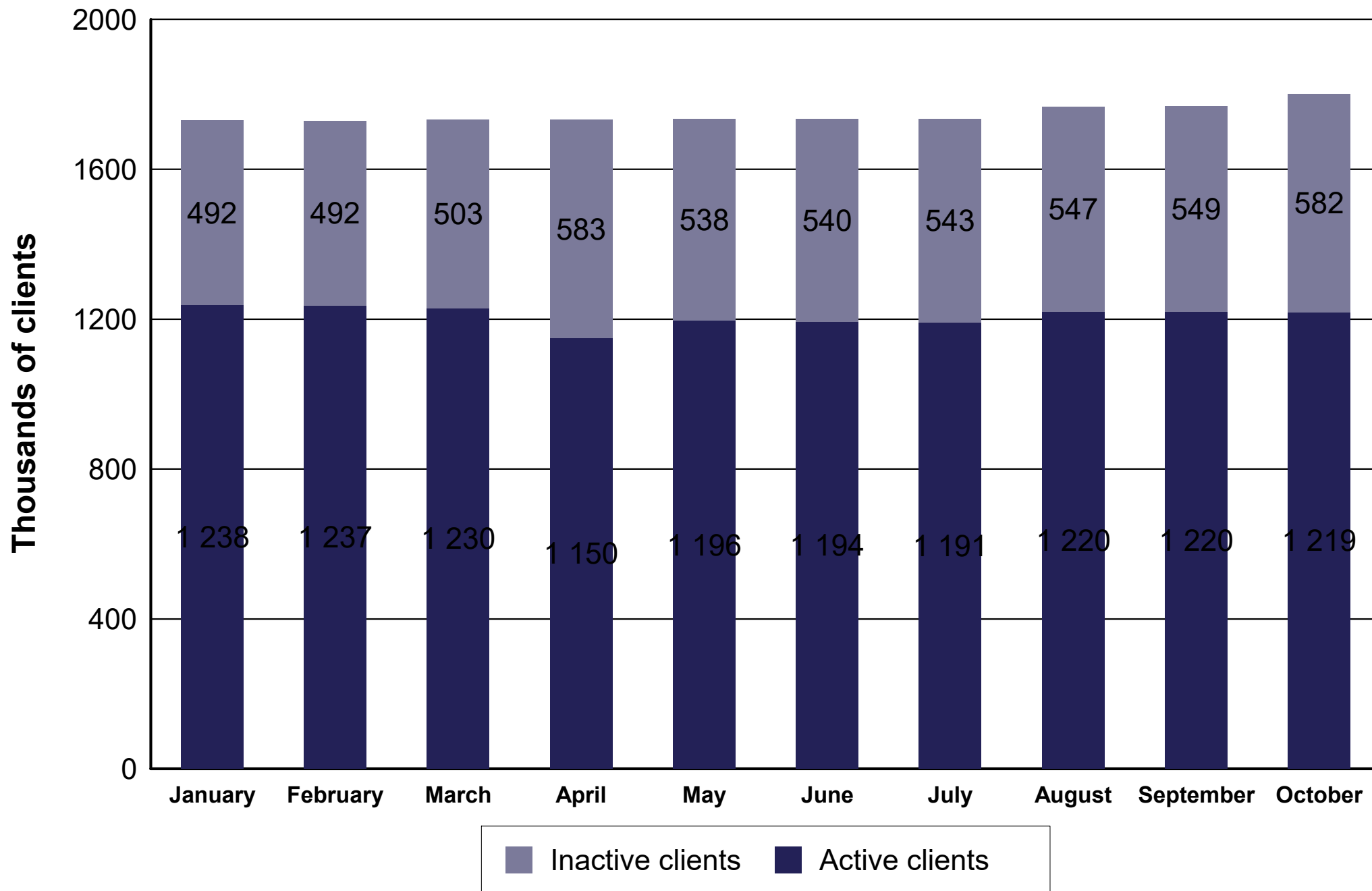

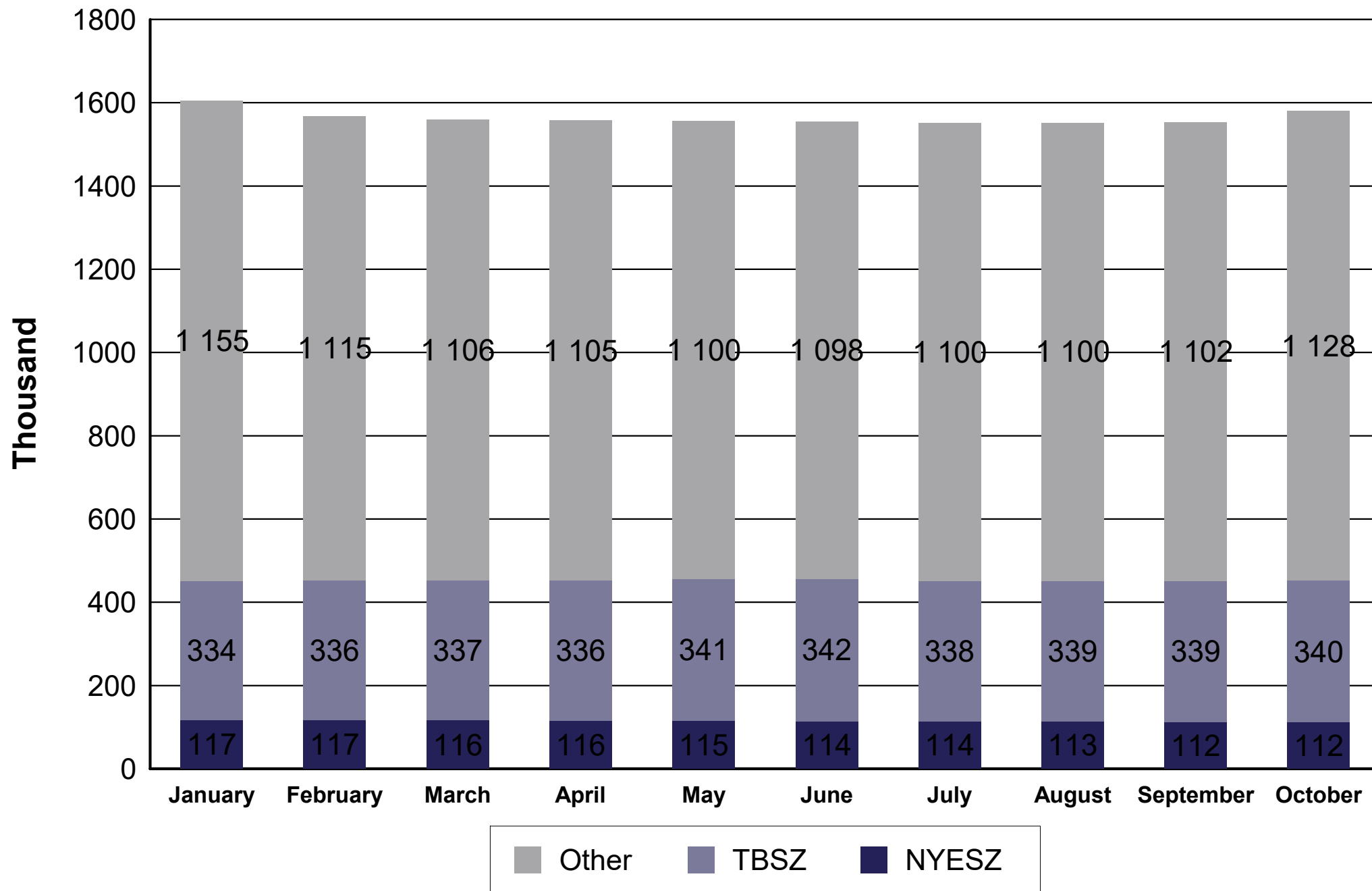

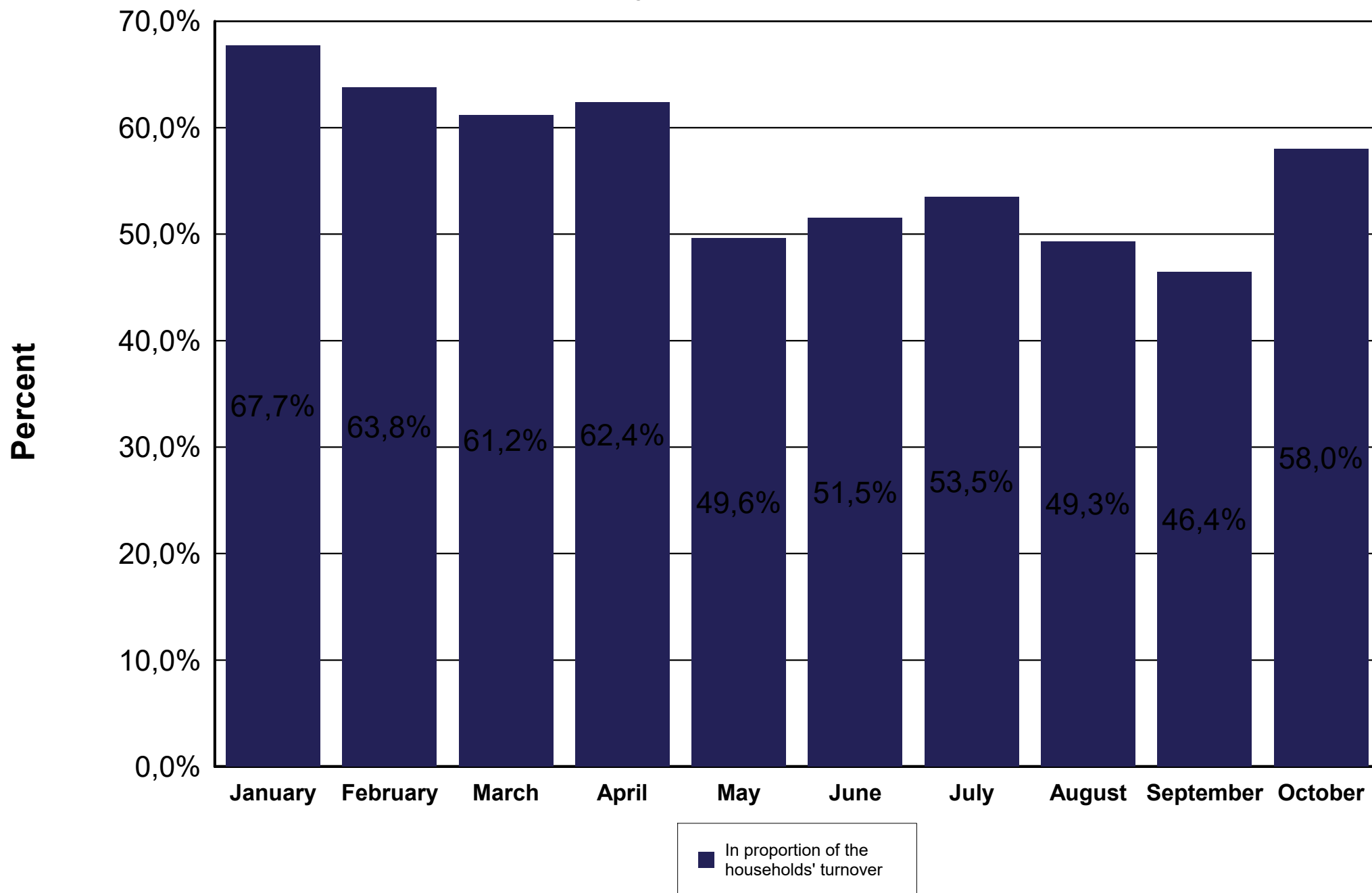

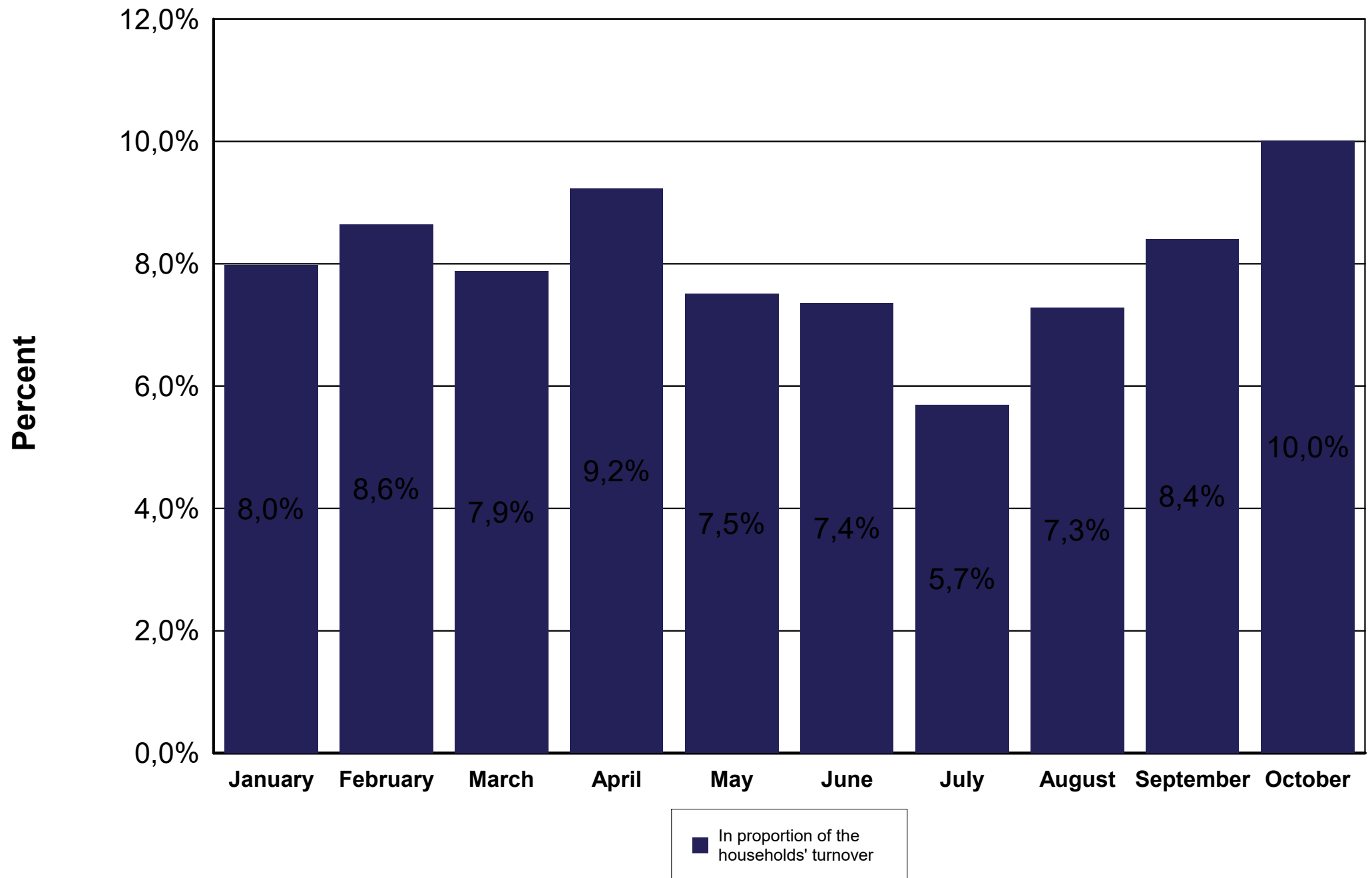

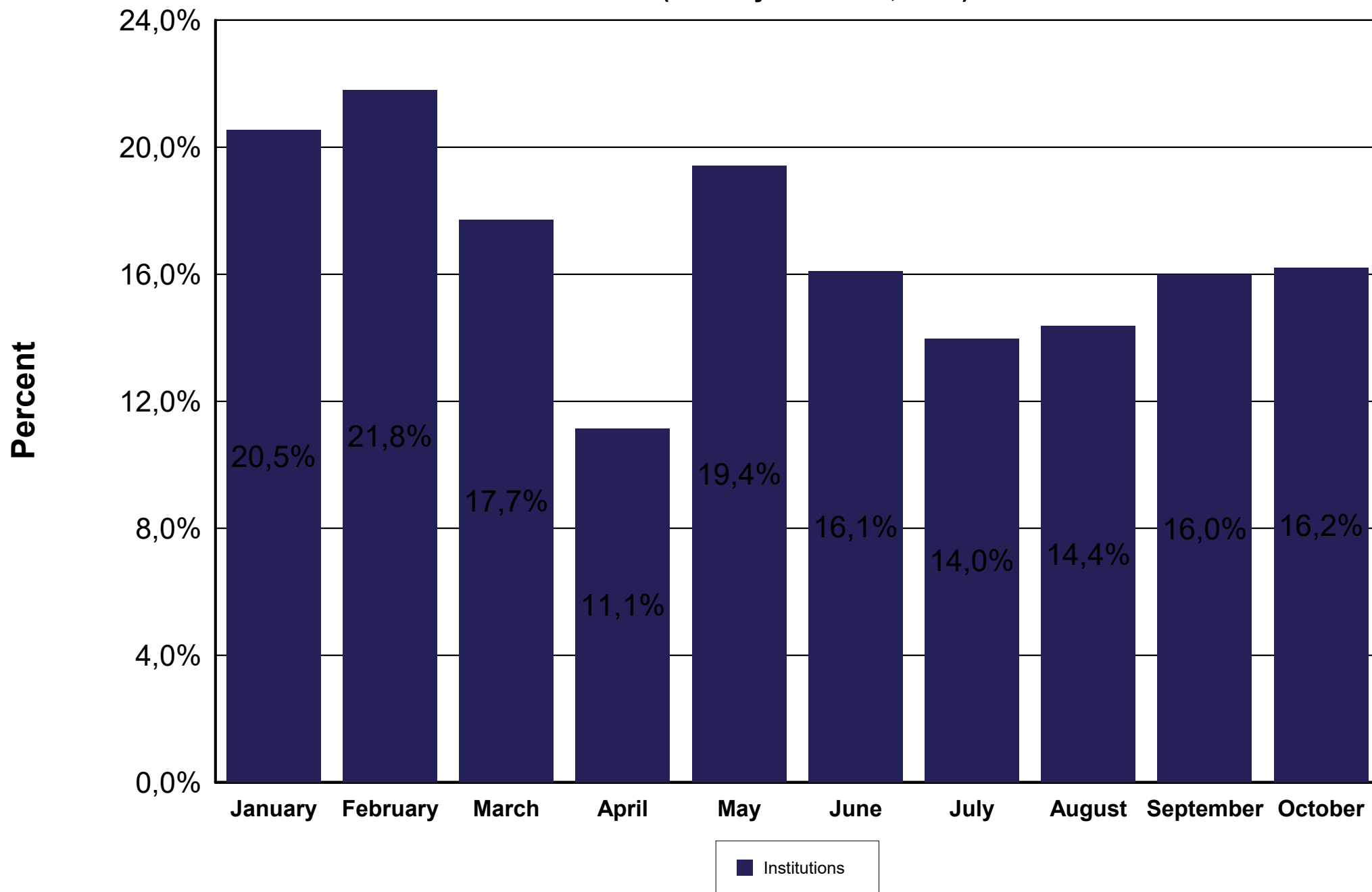
4. table: Transactions executed on the spot market via Internet in proportion of households' turnover
(January - October, 2018)



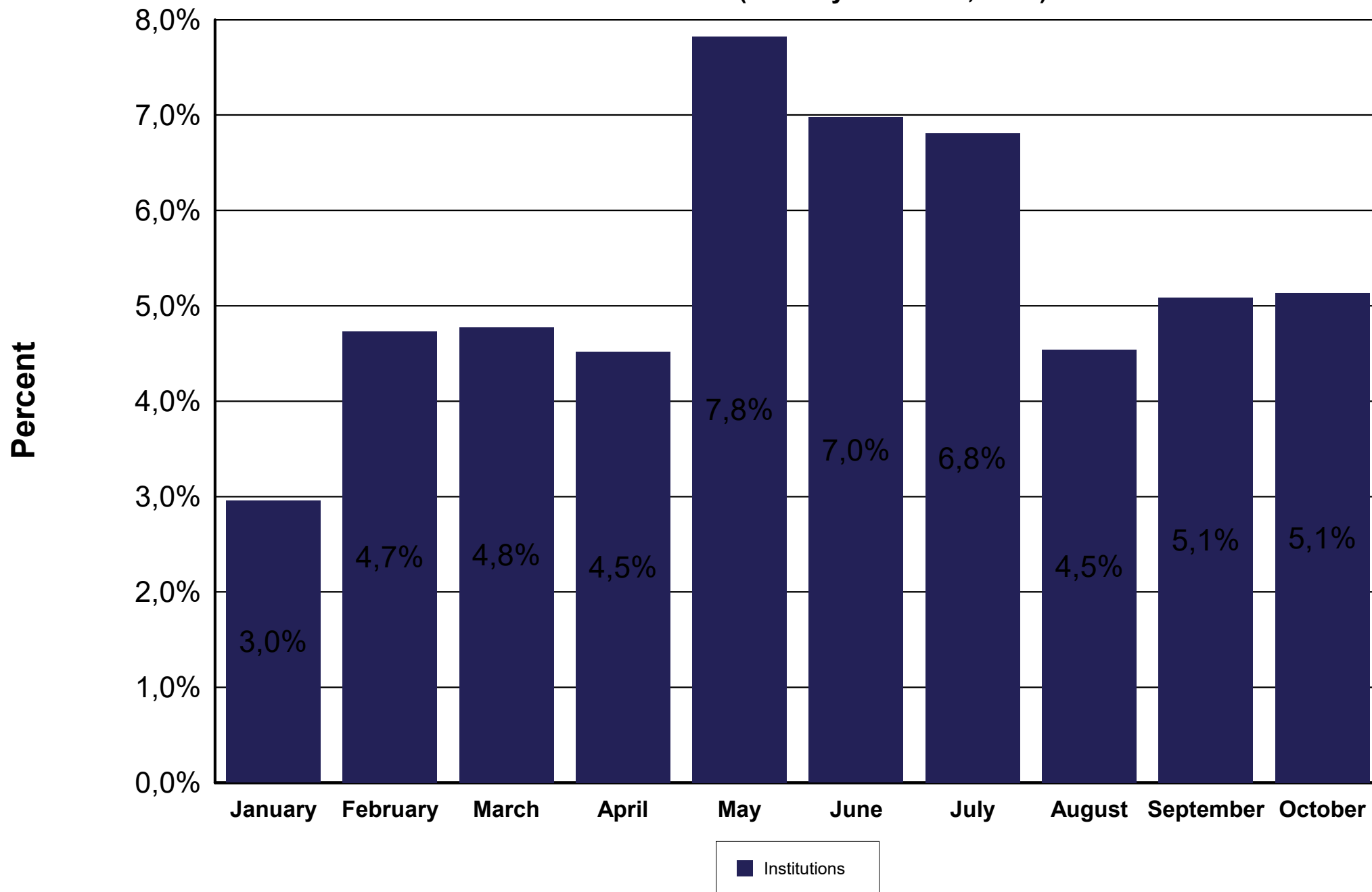

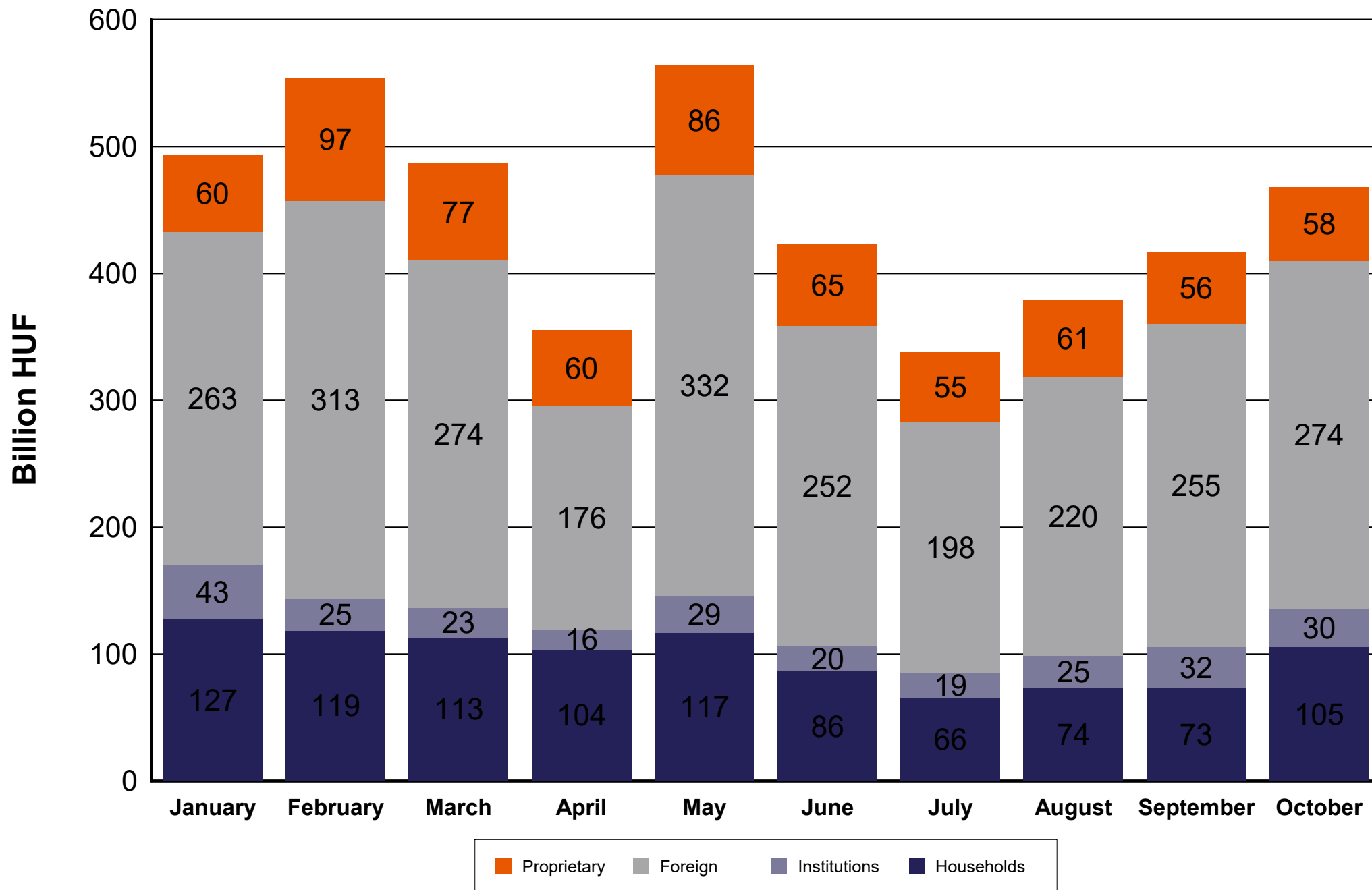

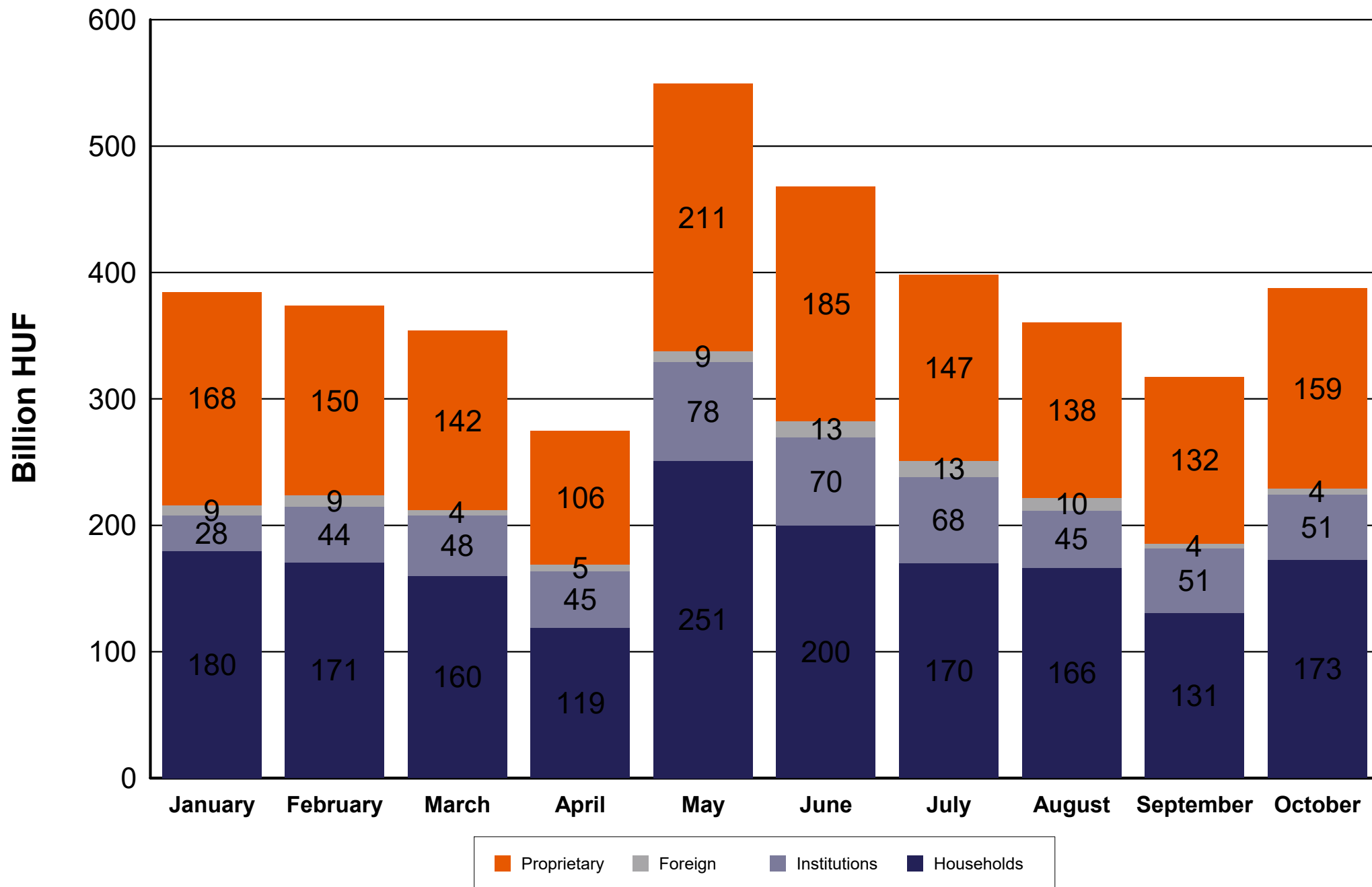

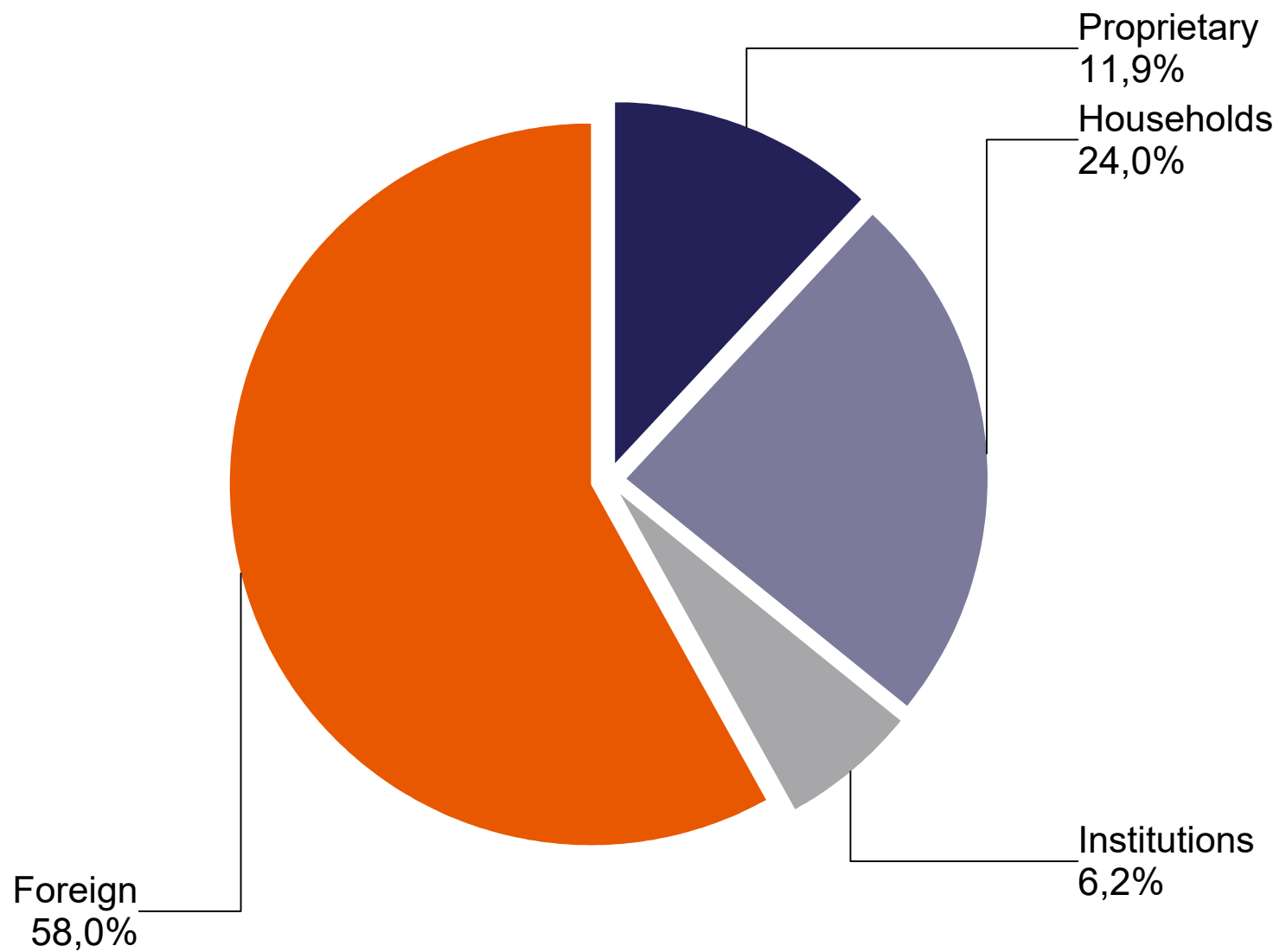
8. table: Breakdown of equity turnover by investor categories (January - October, 2018)



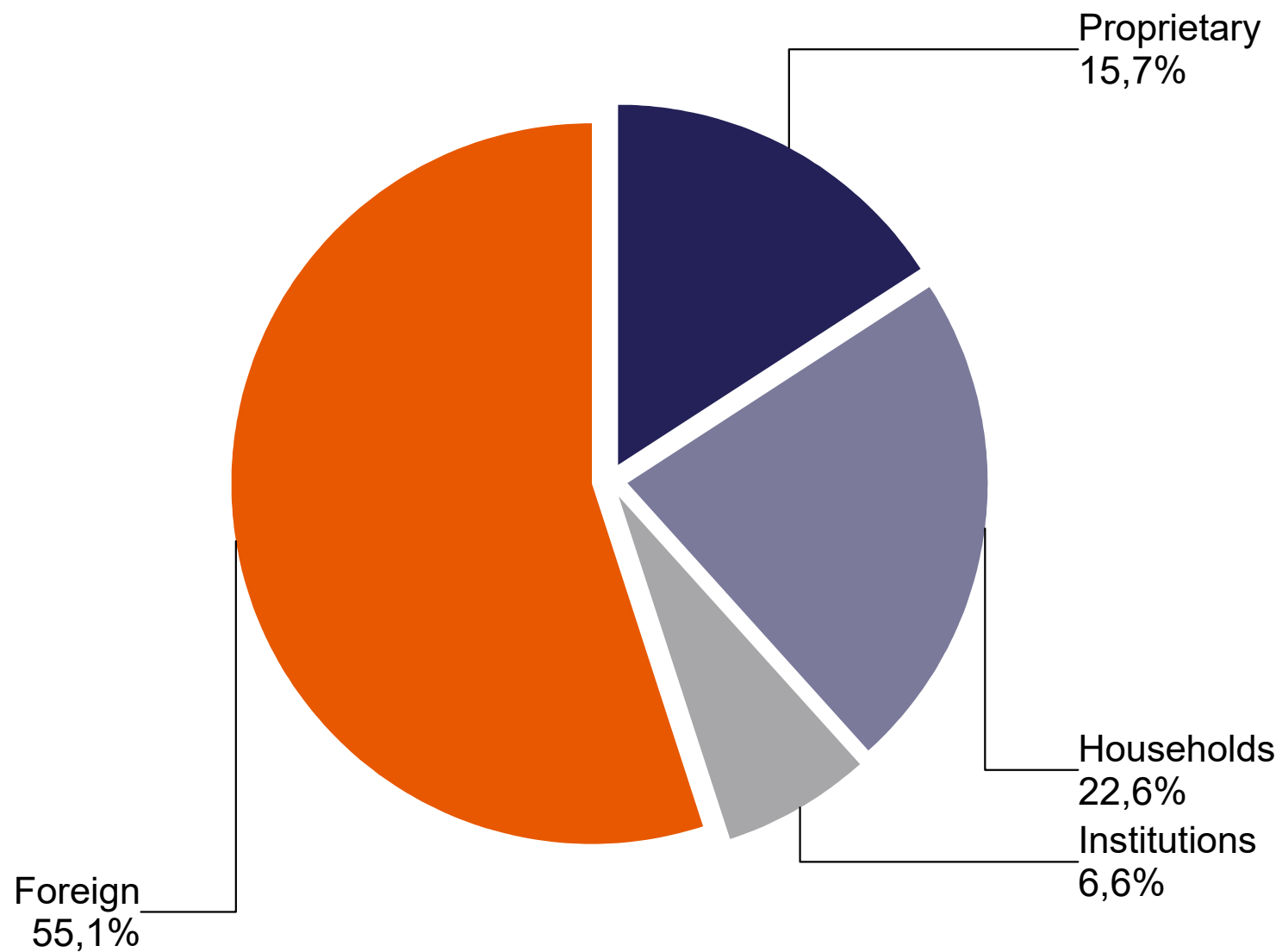
9. table: Breakdown of derivatives turnover by investor categories (January - October, 2018)



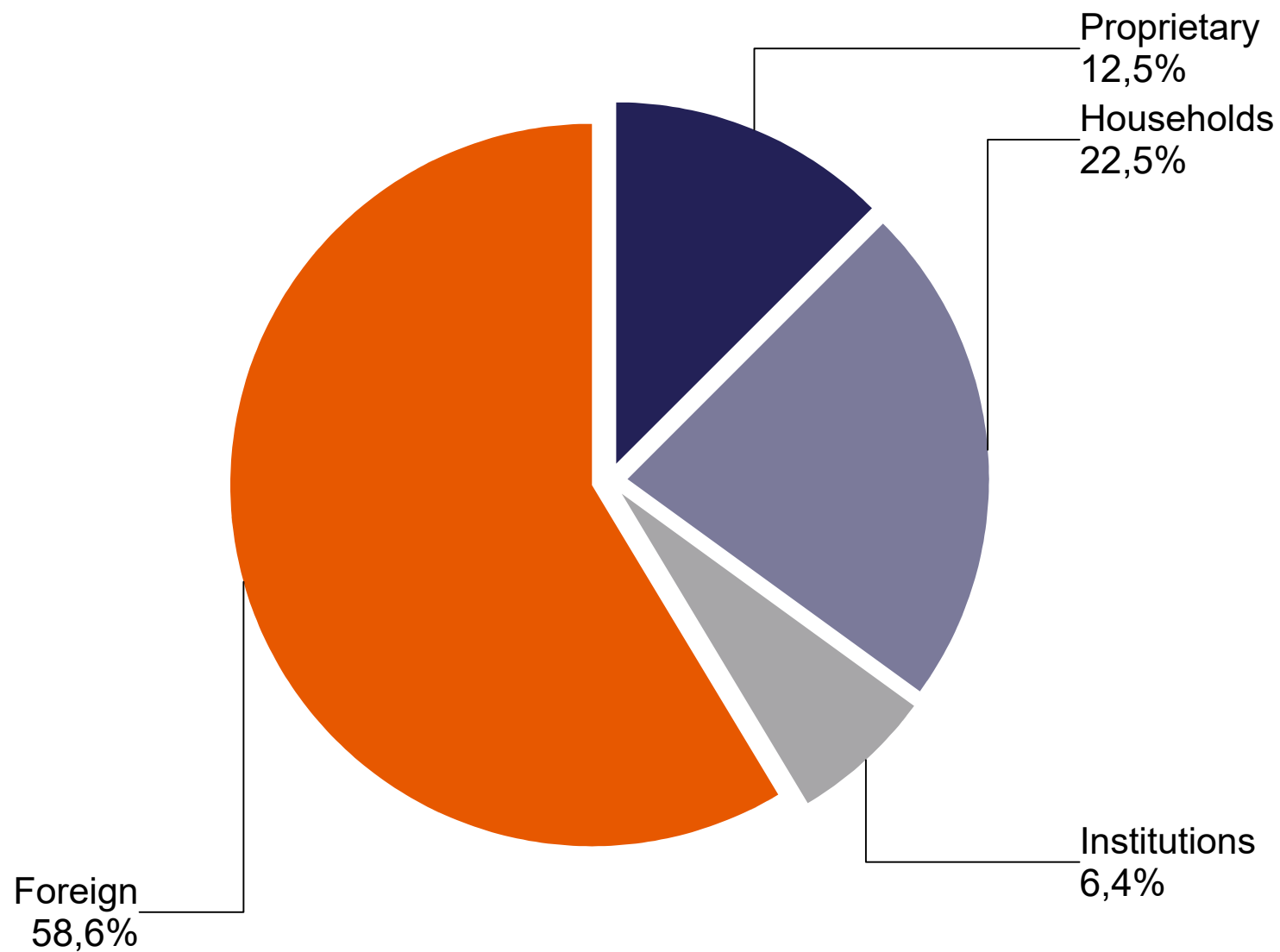

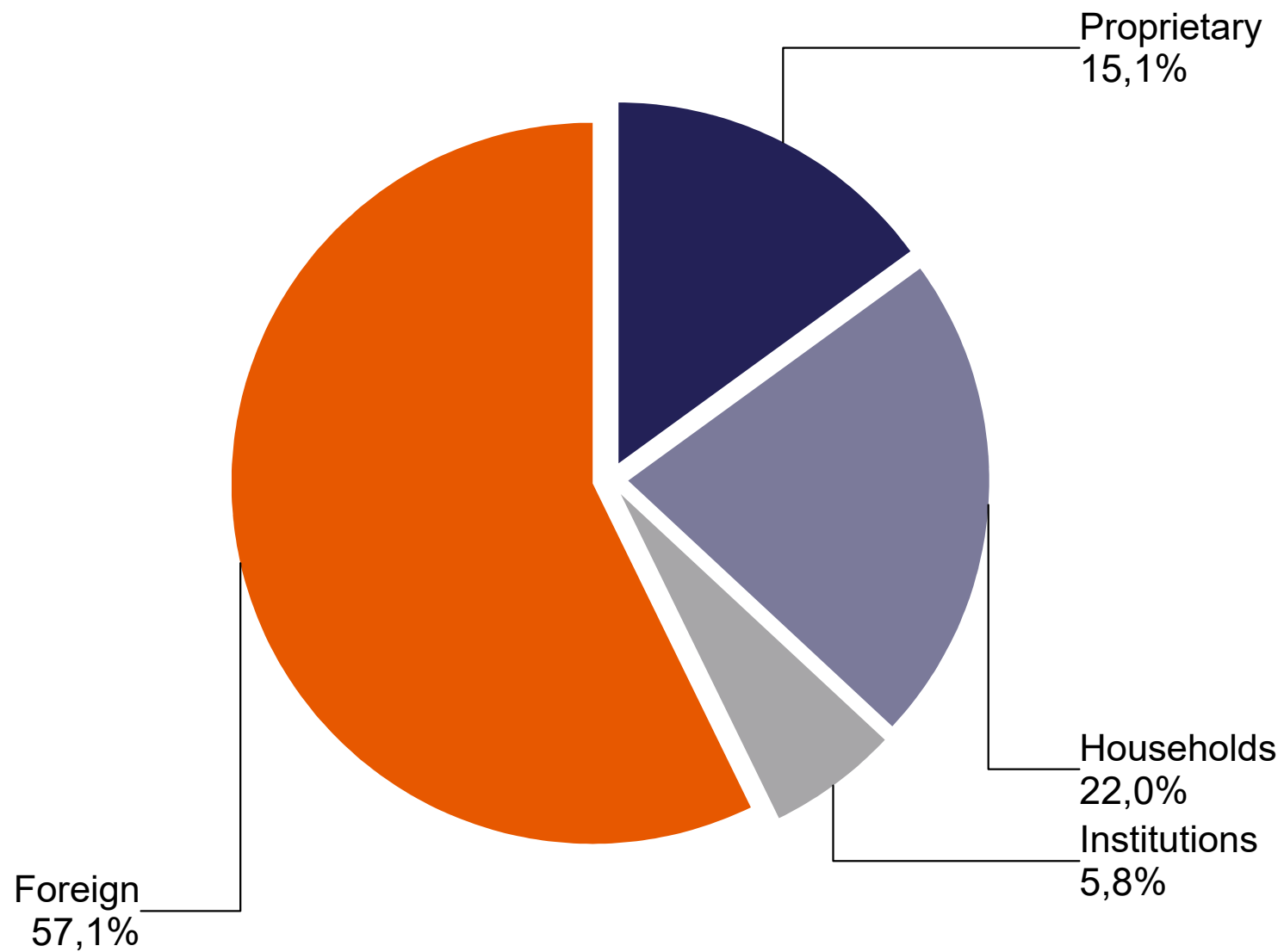

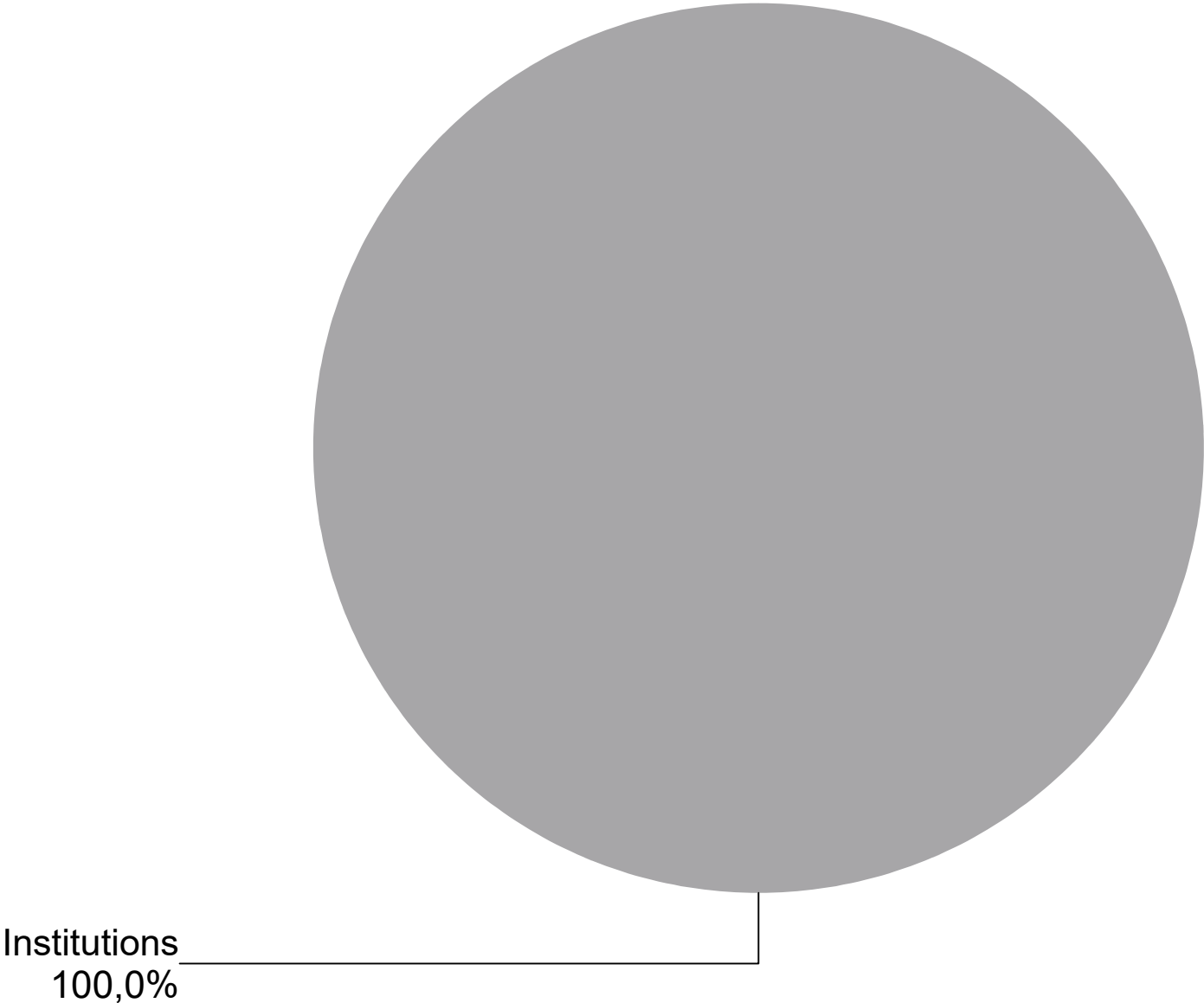

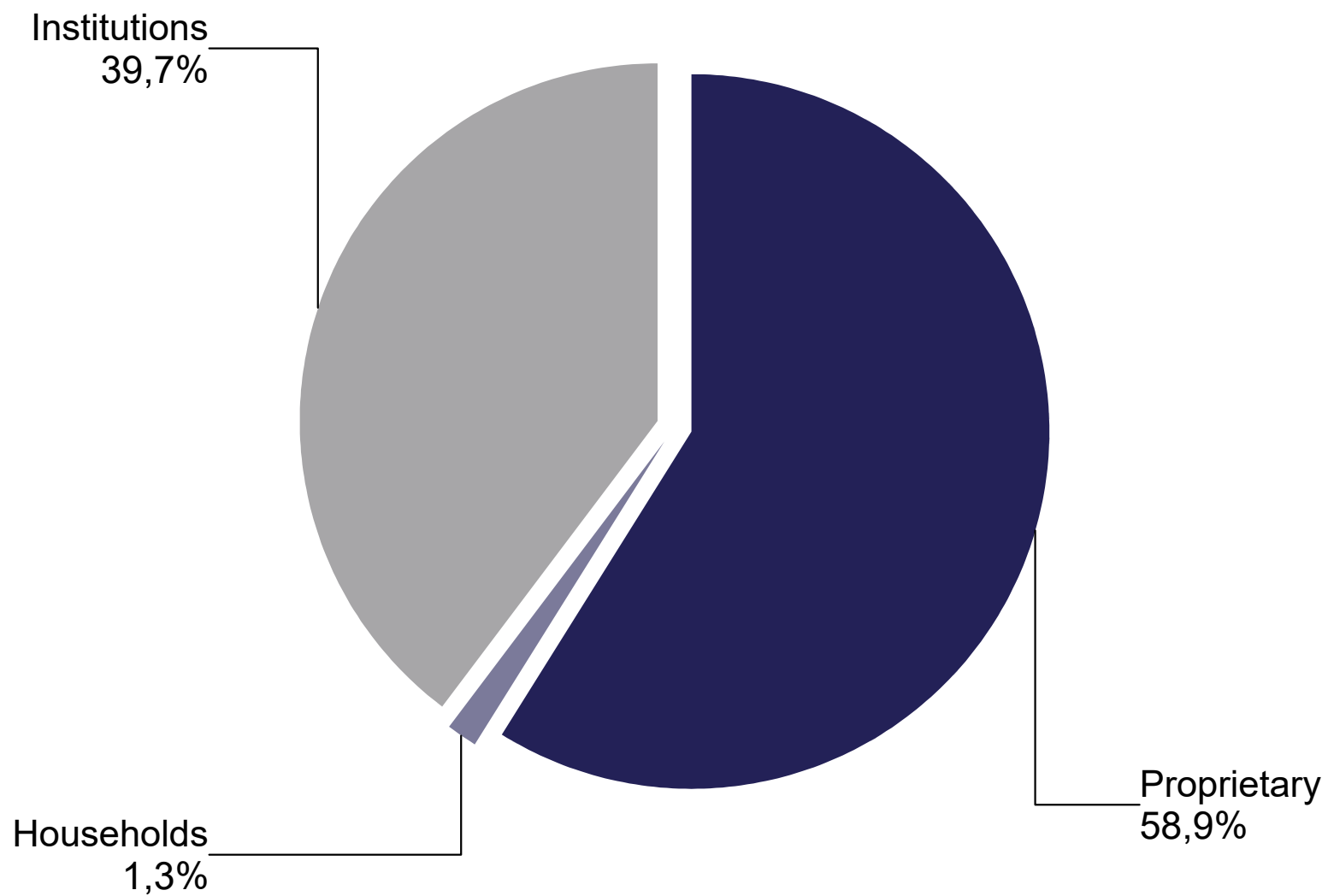

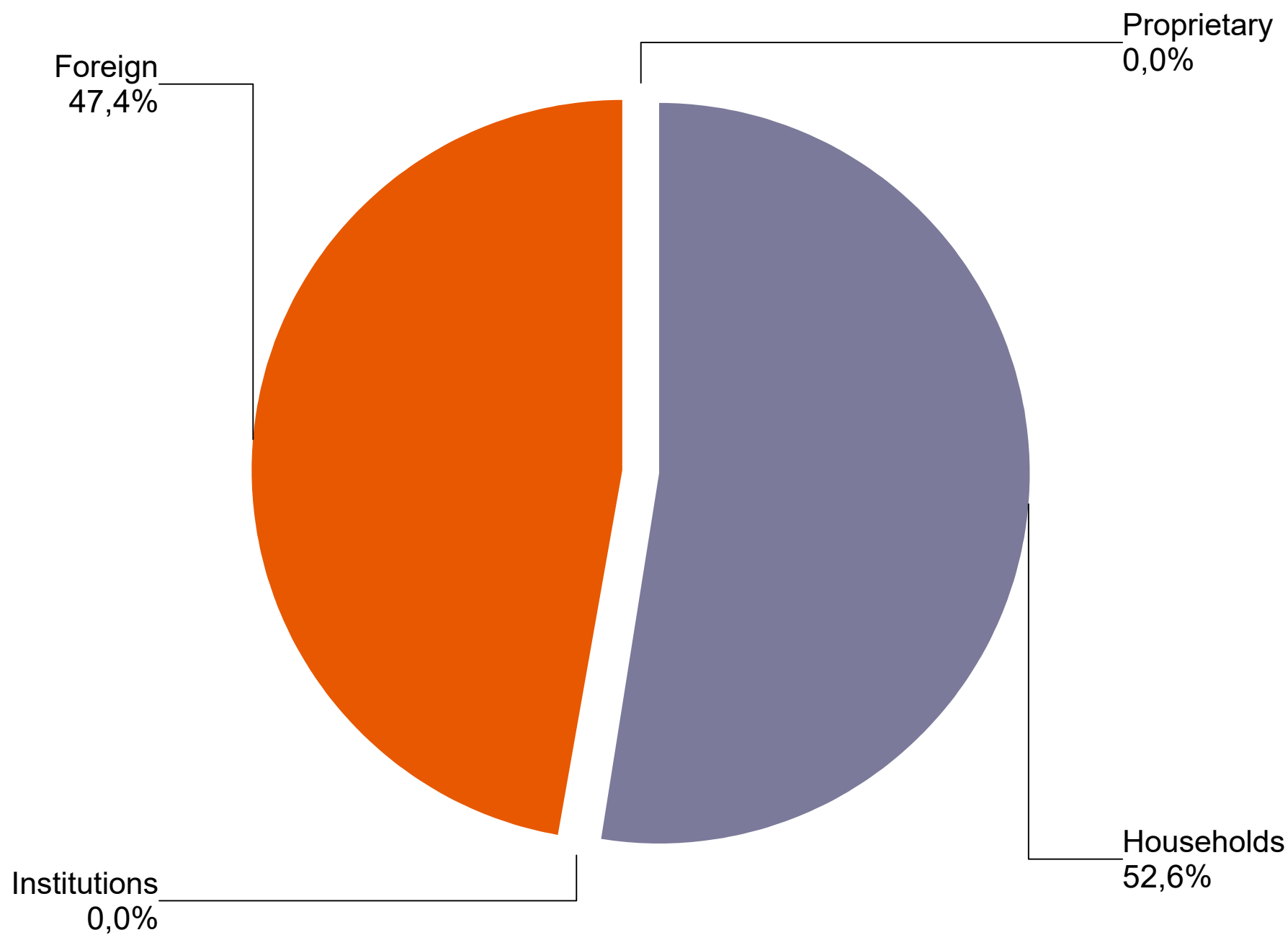

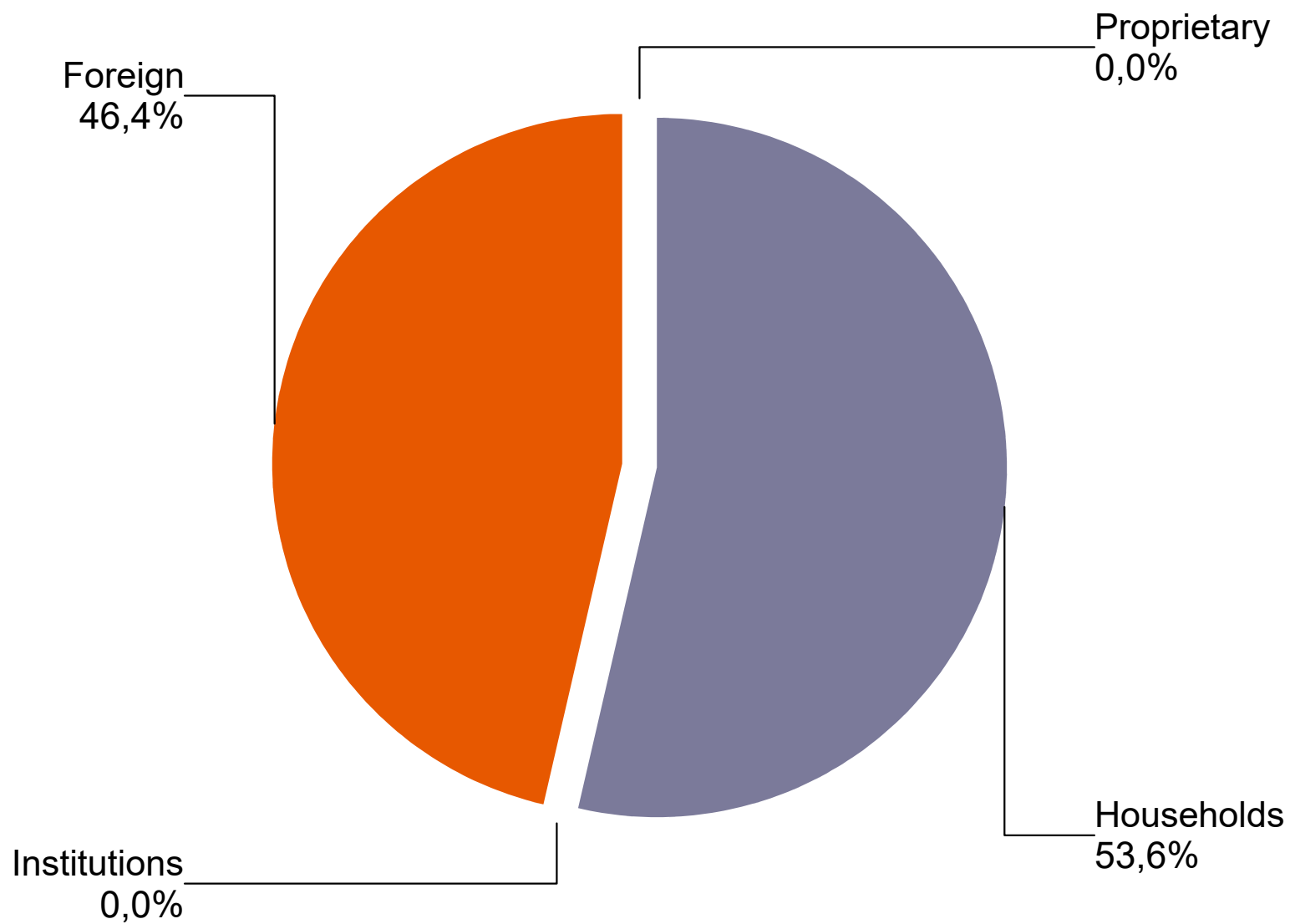

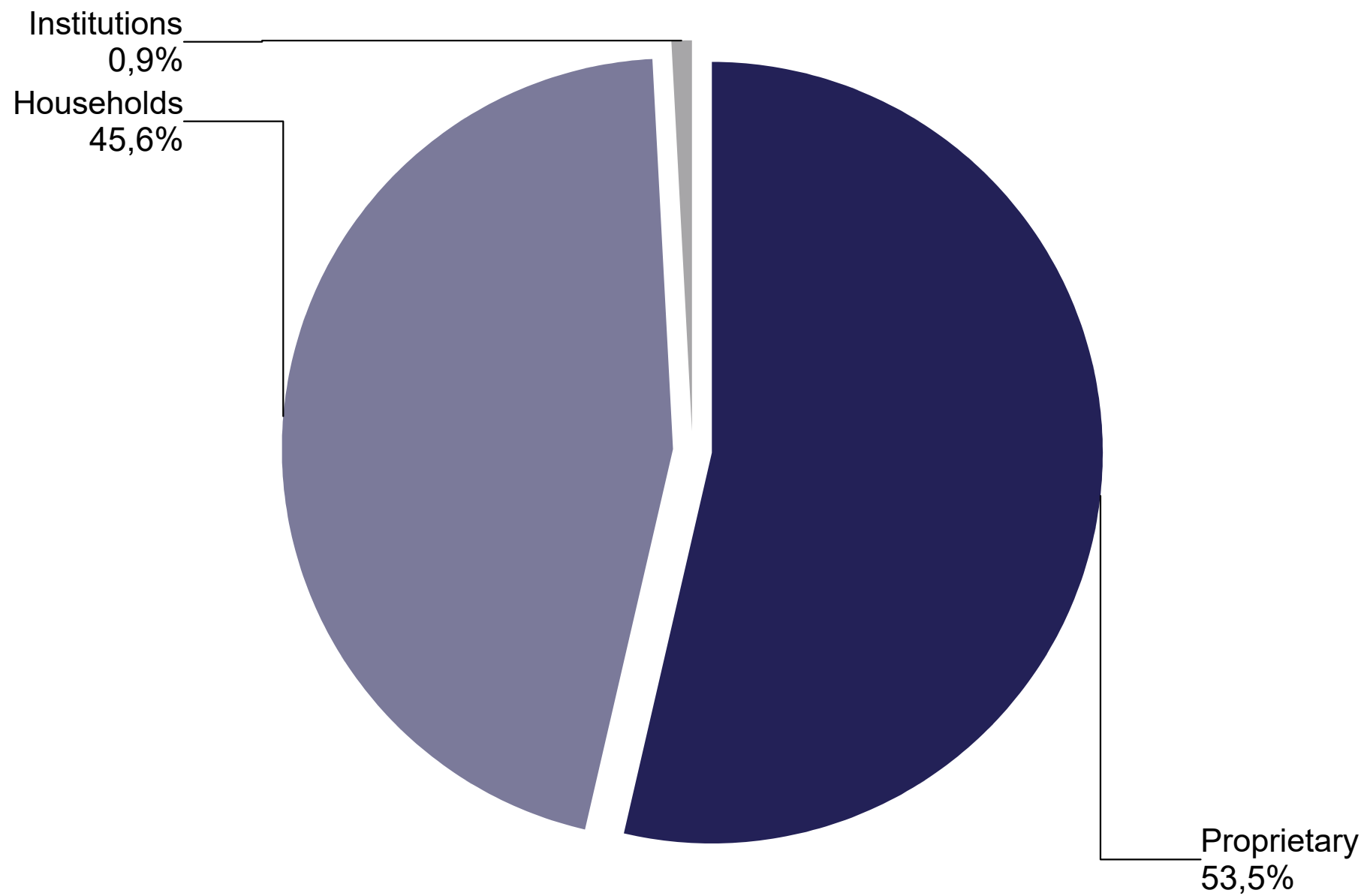

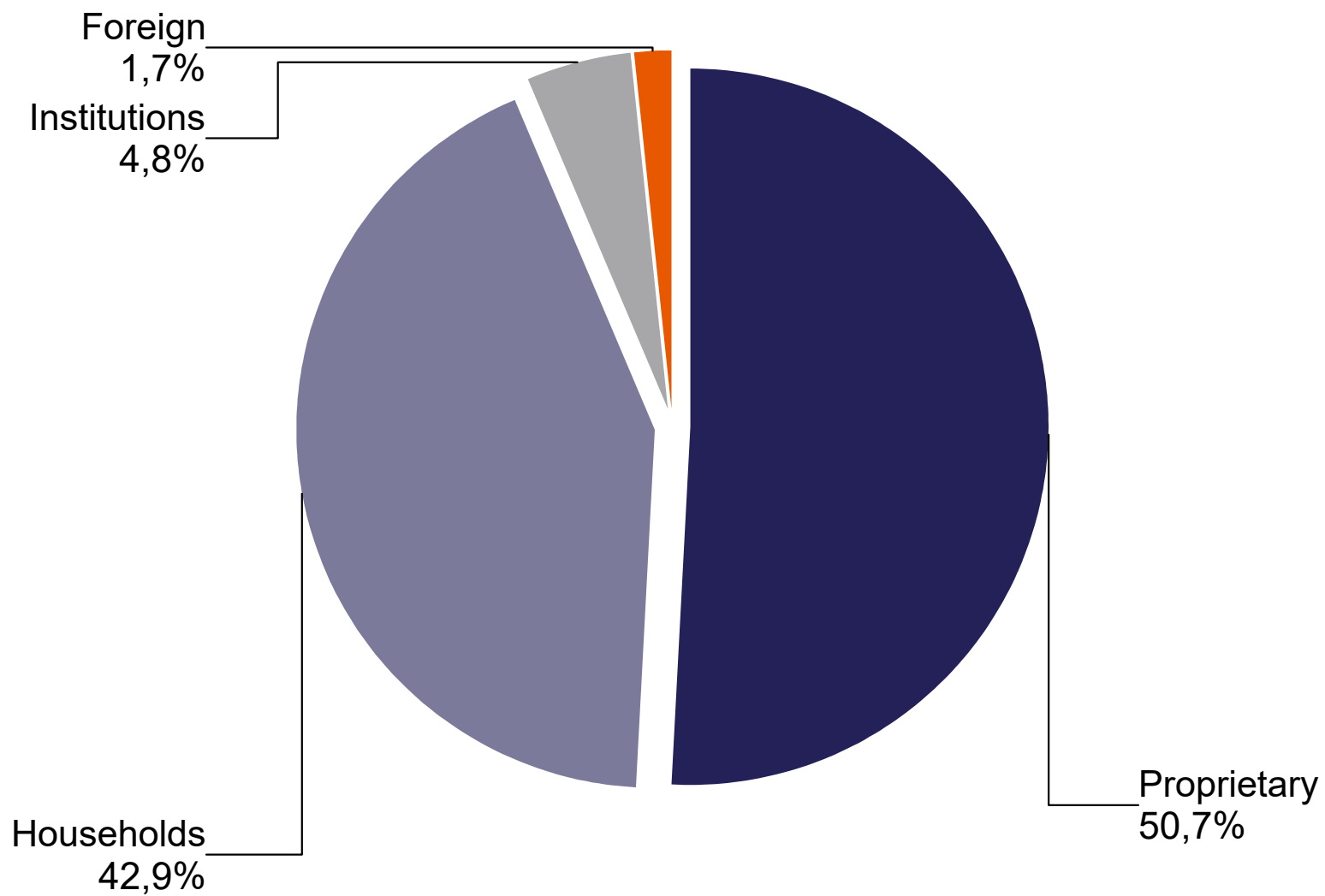

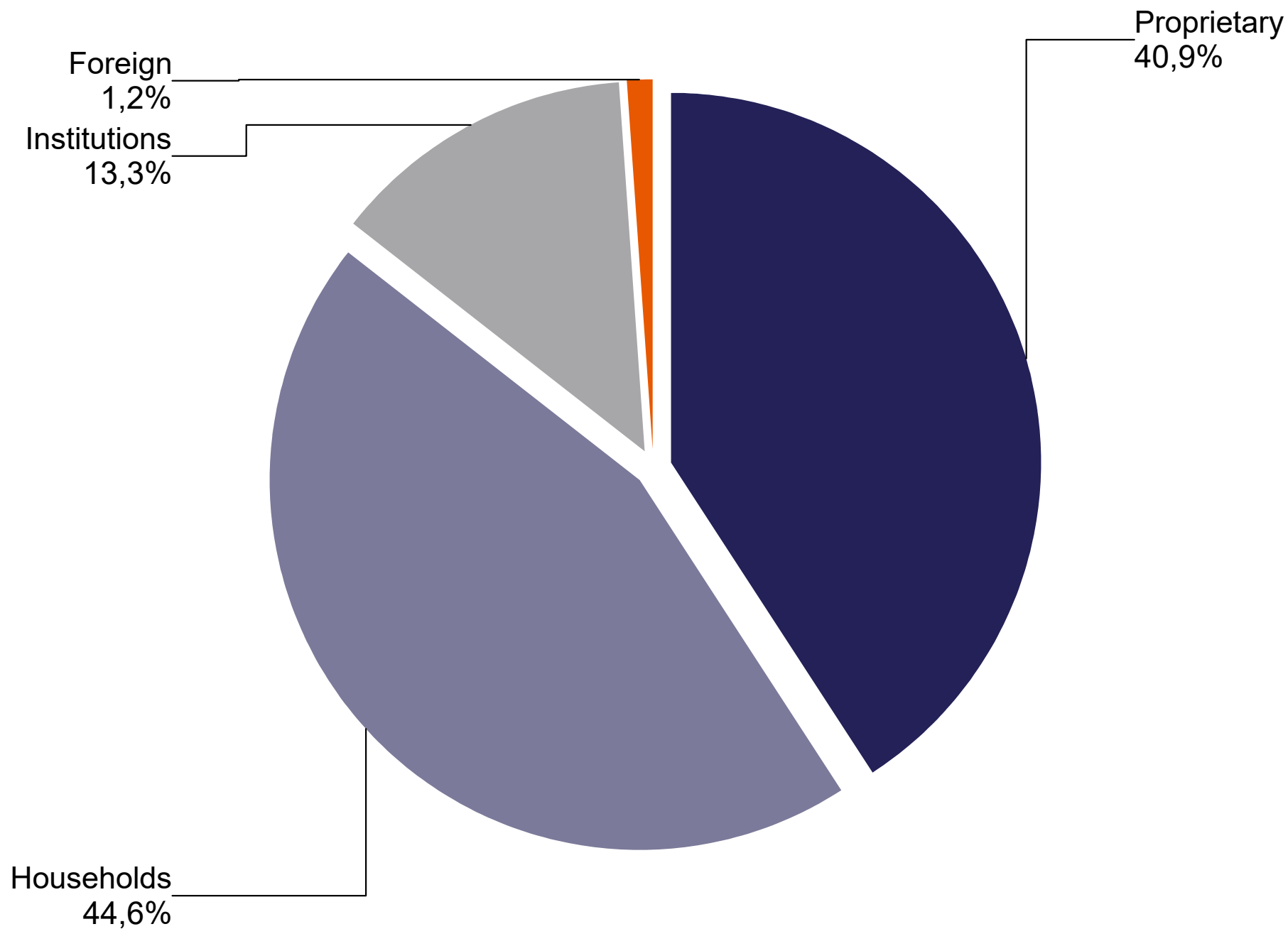

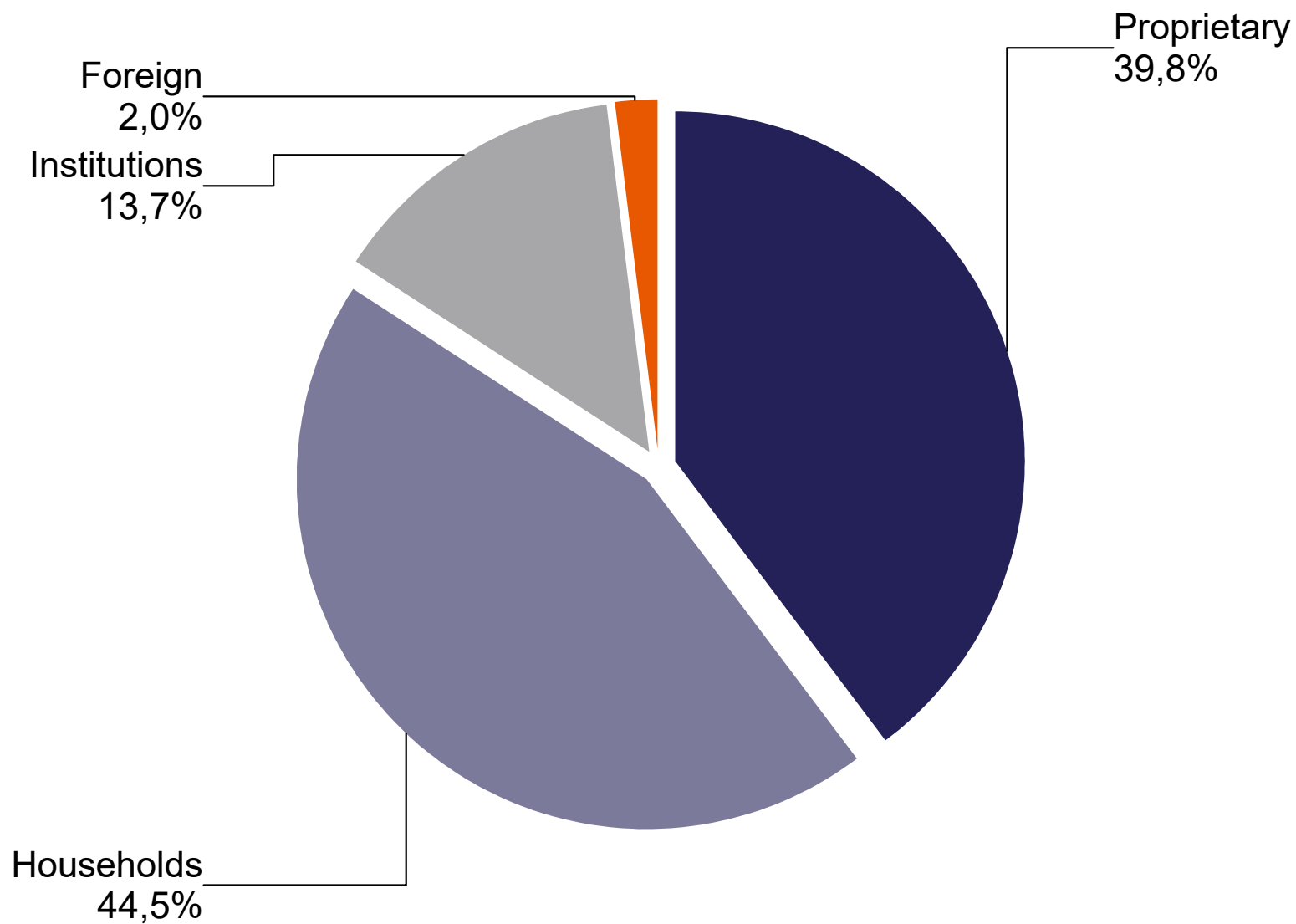

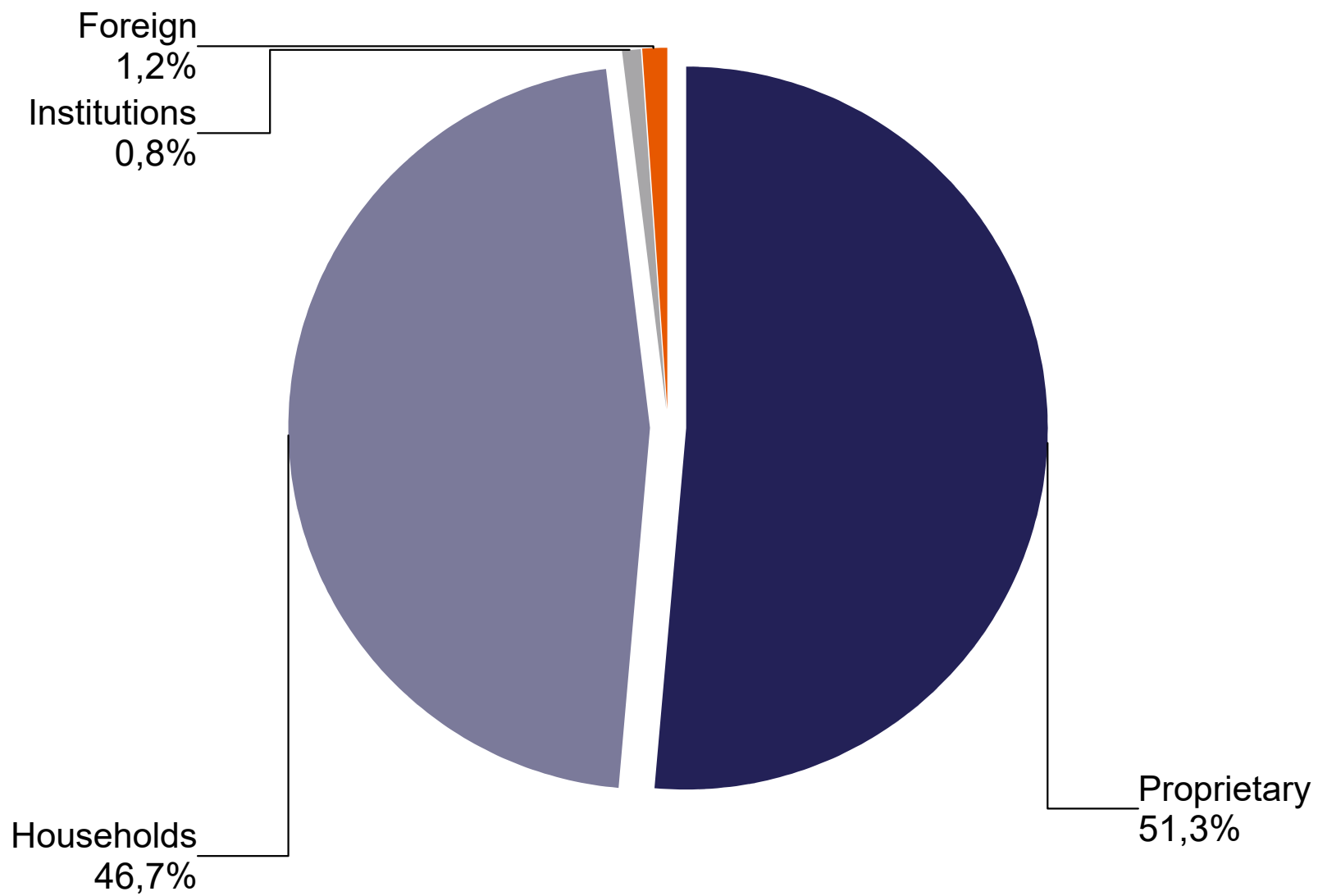

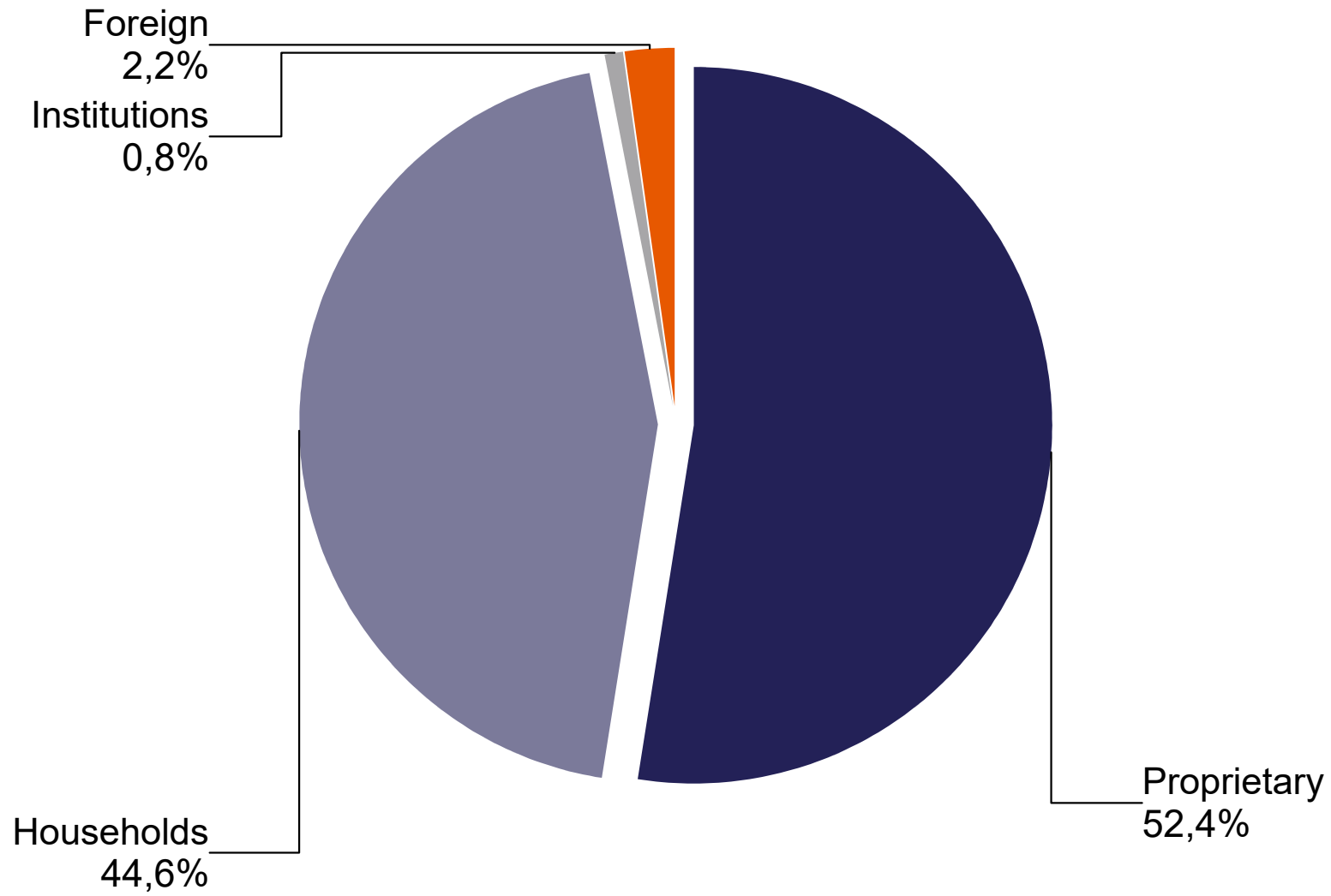

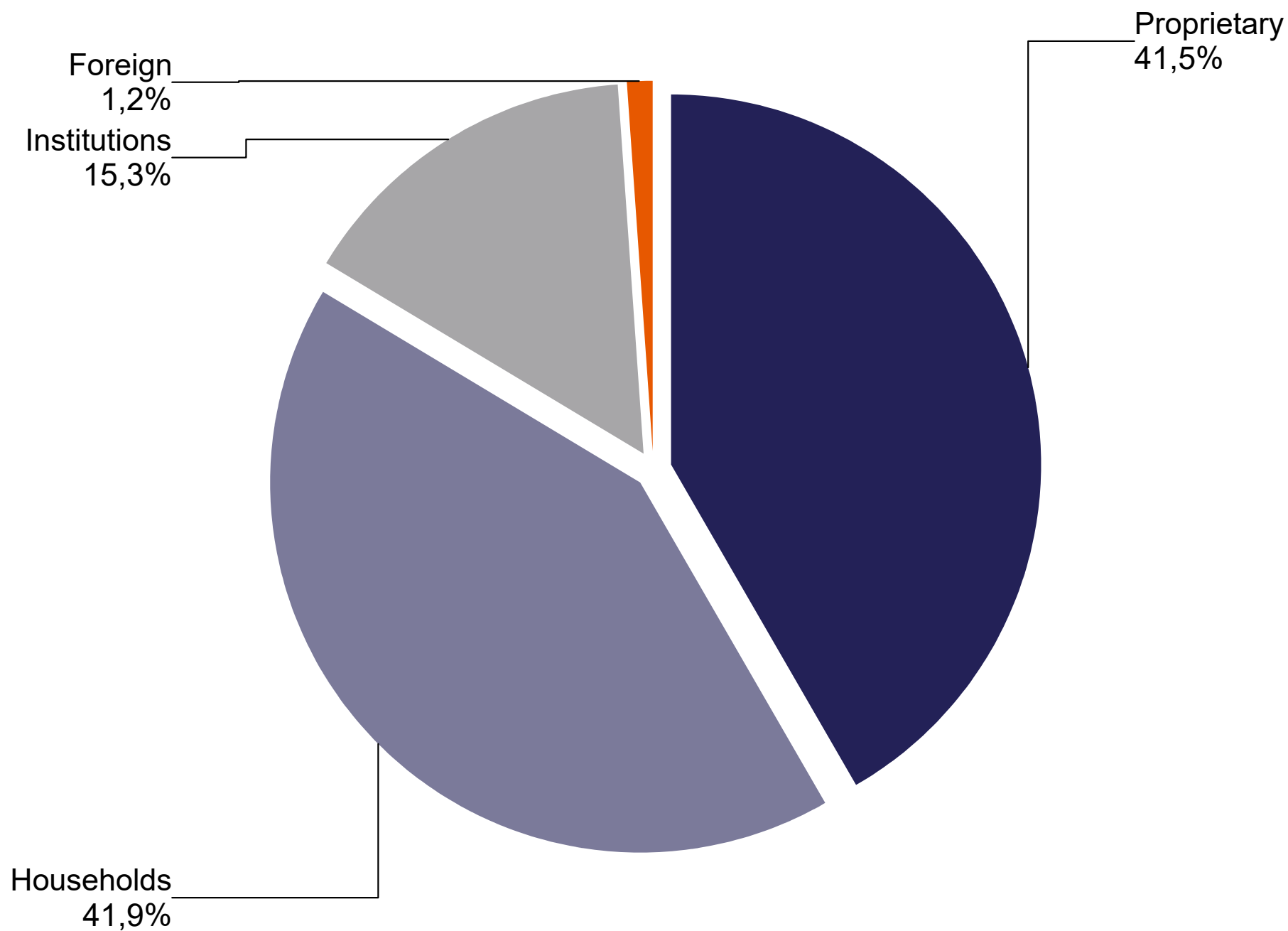

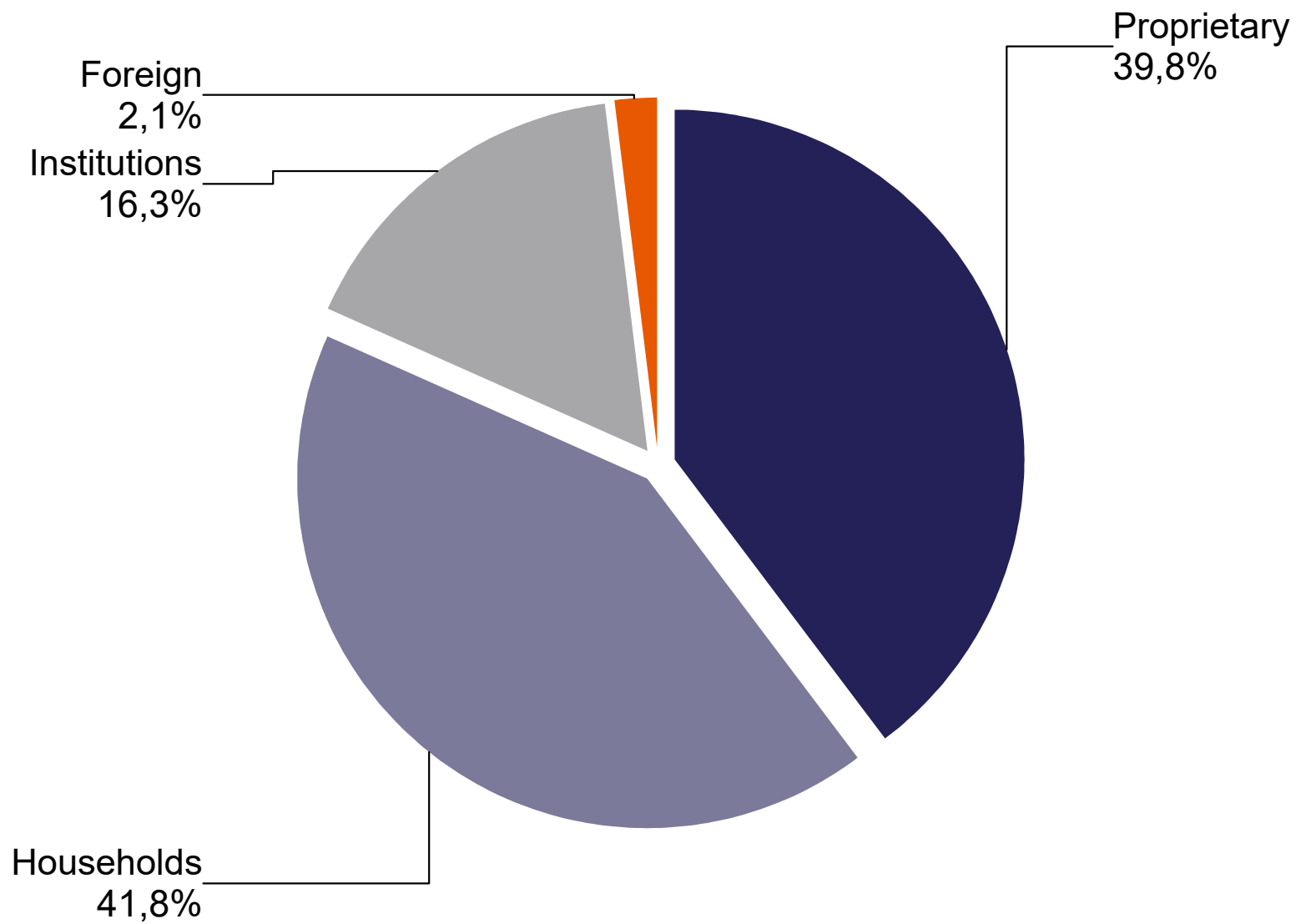

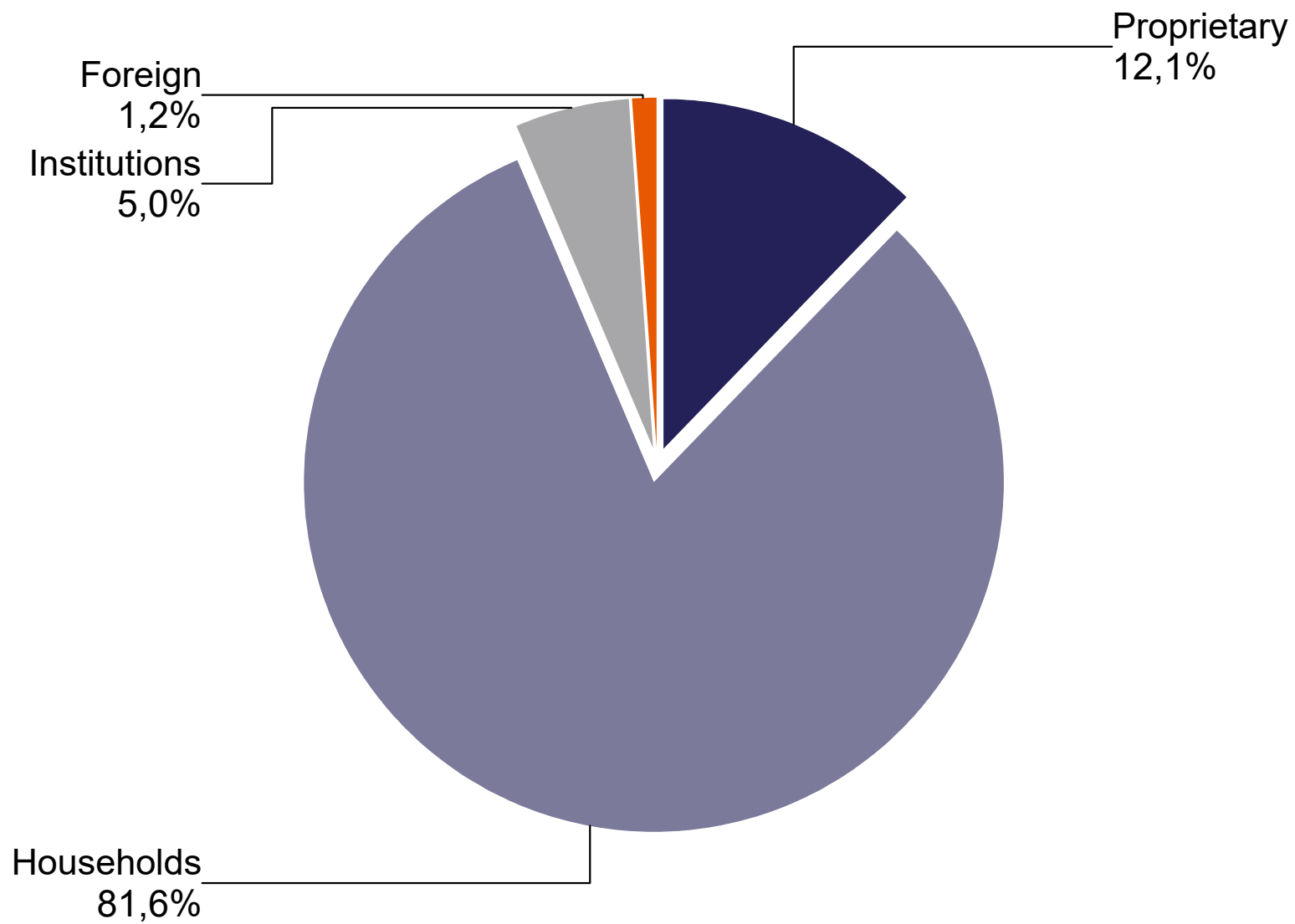
